How does the proposed course specifically address the Foundational Component Area definition above?

This course will introduce students to the discipline of philosophy through an exploration of the life and work of C.S. Lewis (1898-1963), one of the most influential writers of the 20th Century. We will consider his views on a number of philosophical topics, including: the relationship(s) among reason, science, imagination, and faith; the evidence and arguments for and against the existence of God; the problem of evil; atonement; the relationship between God and morality; and the nature, value, cosmic significance, and ultimate destiny of human persons.

- (2) interpret, describe, explain and critique the reasoning behind Lewis's views on a number of perennial philosophical issues;
- (3) evaluate philosophical arguments, propose novel objections, and formulate defenses of philosophical claims; and
- (4) assess the social, political and moral implications of religious commitment.

Strategies and activities for meeting these specific forms of critical thinking include: reading philosophical essays before class; classroom discussions; regular, unannounced quizzes; writing a paper relating a film based on Lewis's fiction to his non-fiction writings; and taking three exams that include objective, short answer and/or essay questions.

Communication (to include effective development, interpretation and expression of ideas through written, oral and visual communication):

Course Learning Outcomes:

- (2) interpret, describe, explain and critique the reasoning behind Lewis's views on a number of perennial philosophical issues;
- (3) evaluate philosophical arguments, propose novel objections, and formulate defenses of philosophical claims; and
- (4) assess the social, political and moral implications of religious commitment.

Strategies and activities for meeting these specific forms of communication learning outcomes include: classroom discussions; writing a paper relating a film based on Lewis's fiction to his non-fiction writings; and taking three exams that include short answer and/or essay questions.

Course Learning Outcomes:

- (3) evaluate philosophical arguments, propose novel objections, and formulate defenses of philosophical claims; and

Strategies and activities for engaging students on issues of social responsibility include: readings and classroom discussions of Lewis's views on the relationship between religion and morality and on the topic of religious exclusivism, inclusivism and pluralism; and taking at least one exam that includes objective, short answer and/or essay questions related to these topics.

Personal Responsibility (to include the ability to connect choices, actions and consequences to ethical decision - making):

**Student Learning Outcomes:** 

- (3) evaluate philosophical arguments, propose novel objections, and formulate defenses of philosophical claims; and
- (4) assess the social, political and moral implications of religious commitment.

Strategies and activities for engaging students on issues of personal responsibility include: readings and classroom discussions of Lewis's views on the destiny of human persons, atonement for wrongdoing, the relationship between religion and morality; and taking at least one exam that includes objective, short answer and/or essay questions related to these topics.
